# <u>Terms of Reference (TOR) for Stall Fabrication (Design, Build up and</u> <u>Dismantle) of Nepal Stall</u>

### Vietnam International Travel Mart (VITM) 2023, Hanoi, Viet Nam

Nepal Tourism Board (NTB) is the National Tourism Organization (NTO) of Nepal established to introduce, develop and promote Nepal as an attractive tourist destination.

As an effort for the fulfillment of the same objective, Nepal Tourism Board is participating in Vietnam International Travel Mart (VITM), 2023 for the destination promotion along with about 06 (Six) travel trade companies of Nepal. Hence, Nepal Tourism Board requires the professional services of Stall Fabricators for design, build up and dismantle of Nepal Stall at **VITM-2023, Hanoi, Viet Nam** as per following details:

#### 1. Fair Details:

Fair Date: 13-16 April 2023

Fair Venue: I.C.E., Hanoi, Viet Nam

#### **Stall Specifications**:

- a. Stall Space: 36 Sq. M. (6 m x 6 m), Three Sides Open
- b. Stand Number and Location: Hall- A2 / Stand Number 80-83
- c. Total Number of Co-exhibitors: 06 (Six ) Plus NTB as Main Exhibitor
- 2. Scope of Work: Design, build up and manage Nepal Stall at VITM-2023 and dismantle the stall after completion of the fair.

#### 3. Specific requirements for Stall Fabrication Package at Nepal Stall:

- 3.1 Design and erect a heritage/culture style thematic Nepal stall using Nepal's iconic tourism products/destinations.
- 3.2 Design, print and paste the required number of graphics of Nepalese tourism attractions on the wall panels. The fabricator should ensure attractive wall panes with sufficient lighting. Required number of raw graphics will be provided to the fabricator by NTB in the available format. The fabricator is responsible to redesign or edit the graphics, if any, in the necessary format as per the requirements of the fabricator.
- 3.3 Place at least one Selfie Photo Booth at the appropriate location of the stall.
- 3.4 The proper management of the remains of the stall after dismantling of the stall will be the sole responsibility of the fabricator.





- 4. Provide/manage all necessary logistic arrangements required for the stall as follows:
  - a) Flooring with carpet/wooden parqueting in the stall
  - b) 1 (One) Main reception counter table for Nepal Tourism Board as the Main Exhibitor with two chairs in the prime location of the stall.
  - c) 24 Counter Tables (lockable) for Co-exhibitors with 2 chairs for each. Each Counter Table should have branding with the Name and Logo of the respective company (Co-exhibitors)
  - d) Make sure that there is panel separator with enough space between the coexhibitors to maintain privacy.
  - e) Placement of the co-exhibitors' counter tables towards aisle side facing walk ways in the halls.
  - f) 6 (Six) sets of small round meeting tables with required number of chairs for meeting purpose for the co-exhibitors.
  - g) Special seating arrangement with 1 sofa set and tea table for NTB (partially closed VIP meeting area).
  - h) Nepal Brand Logo should be prominently visible to the visitors and the exhibitors.
  - i) Required Electrical supply and sufficient lighting for the stall, with plug points/sockets for each counter. Moreover, it is the sole responsibility of the Fabricator to coordinate with the organizer to ascertain the required amount of electricity supply to fulfil the required demand of electricity as per the TOR. NTB shall treat the supply of electricity as a part of the fabrication. No extra payment shall be made separately for electricity supply neither to the Organizer nor to the Fabricator by NTB.
  - j) Wi-Fi/Internet Facility within stall accessible to the exhibitor and all the coexhibitors.
  - k) Storage room with lockable door in the stall with sufficient shelves and hangers.
  - 1) Cost for rigging including charges for rigging points shall be borne by the respective fabricator if it is included in design.
  - m) Audio/visual display with LED Wall /LED Screen.
  - n) Pedestal to place Buddha statue in an appropriate location (Buddha Statue shall be provided by NTB)
  - o) One bigger dustbin for store and required number of small ones in between counters.
  - p) 1 coffee vending machine and a water dispenser with necessary supplies including disposable cups for all three days of the fair.
  - q) Hot/cold water dispenser with supplies for all the fair days (including disposable cups)
  - r) Service Table/counter next to store room to serve snacks/tea coffee



- s) Banner/standee to be kept in any visible area, displaying all co-exhibitors' names
- t) Some plants at the possible places/corners in the stall
- u) Stall cleaning service for all 3 (Three) days of the fair.
- v) Any other effective creative elements and services for the value addition in Nepal's participation.
- **5.** The selected company shall deal with the organizer in getting all technical approvals/permission/electricity supply/internet/ water connection, etc.
- **6.** Nepal Tourism Board shall not make any payment for the design or submission of quotation/proposal, which is not selected for the job.
- 7. The payment terms shall be as provisioned in Agreement between Nepal Tourism Board and the selected stand designer/fabricator company.
- **8.** All necessary designs/graphics/posters to be put in the stall are to be approved by Nepal Tourism Board before final work of printing and pasting.
- **9.** Nepal Tourism Board may ask the selected fabricator to make necessary changes if any, in the design submitted without violating the basic design.
- 10. The selected fabricator should quote the price including all applicable taxes (If any) in US Dollar. In case if the fabricator quotes the price in any other currency, it will be evaluated for selection purpose based on the Nepal Rastra Bank (Central Bank of Nepal) Currency Exchange rate on the day of bid opening. However, if a company based/registered in India applies, such company has to submit/bid the proposal/quotations in Indian Currency. If such Indian company wins the bid and is awarded the job, in such condition, the company shall be paid in Indian currency.
- **11.** All the necessary technical approval for the stall design, build up and dismantle should be taken by the selected Stall designer Company from the organizer.
- **12.** The bid proposals shall be evaluated and selected on the basis of the following evaluation criteria:
