

<u>Terms of Reference (TOR) for Stall Fabrication of Nepal Stall at TTF</u> <u>Ahmedabad 2018, Ahmedabad, India</u>

Nepal Tourism Board (NTB) is the National Tourism Organization (NTO) of Nepal established to develop, introduce and promote Nepal as an attractive tourist destination. As an effort for the fulfillment of the same objectives, Nepal Tourism Board is participating in TTF Ahmedabad 2018, Ahmedabad, India, along with 6 (Six) co-exhibitors from Nepal. Hence, Nepal Tourism Board requires the professional services of stall fabricators for design, build up and dismantling of Nepal Stall at TTF Kolkata 2018, Kolkata, India as per following details:

1. Fair Details:

Fair Date: 07-09 September 2018

Fair Venue: Gujarat University Exhibition Hall

Stall Specifications as follows:

a. Stall space: 54 Sq. m. (18X3), Two Side open

b. Stall No: A500 (Marked in the Layout)

c. Total number of Co-exhibitors: 6 with NTB as Main Exhibitor

2. Specific requirements for Stall Fabrication Package for Nepal Stall:

- 2.1 Design and erect a heritage/culture style thematic Nepal stall using Nepal's iconic tourism products/destinations and showcase the beautifully designed graphics of Nepalese tourism attractions on the wall panels. NTB will send only the raw pictures/images as per the need of the fabricator. Design of the graphics/images, editing, change of image formats (if necessary), printing and pasting will be the sole responsibility of the fabricator (graphics to be finalized upon submission of the stall design).
- 2.2 Provide all necessary logistic arrangements required for the stall including:
 - a) Flooring with carpet in the stall.
 - b) 1 (One) Main reception counter with branding for NTB with two chairs facing isle in the prime location of the stall.
 - c) Other 6 (Six) counters (lockable) for co-exhibitors with 2 chairs each on the same side with sufficient space in between (no bar stools). All Counter Tables should have the Name and Logo of the respective Company (Co-exhibitors).
 - d) 2 (Two) sets of round table with 3 (Three) chairs each for meeting purpose for co-exhibitors.
 - e) Special seating arrangement with 1 (One) sofa set and tea table (if only space permits).

- f) Nepal Brand and Signage should be prominent and visible to the visitors and the exhibitors.
- g) Placement of the co-exhibitors counter towards aisle side directly facing walkways in the halls.
- h) Electrical supply and sufficient lighting for the stall, with plug points/sockets for each counter.
- i) Storage room with lockable door in the stall with shelves and hangers.
- j) Audio/visual display with LED screen.
- k) Wi-Fi/internet facility within stall accessible to the exhibitor and all the co-exhibitors.
- 1) 1 (One) bigger dustbin for store and other required number of small dustbins in between counters.
- m) Banner/standee to be kept at the corner of the stall or in any visible area, displaying all co-exhibitors names.
- n) 2-4 plants at the possible places/corners in the stall.
- o) Set up 1 (One) coffee vending machine and 1 (One) water dispenser with necessary supplies for all three days at the appropriate place in the stall.
- p) Stall cleaning service for all 3 (Three) days of the fair.
- q) Any other effective creative elements for the value addition in Nepal's participation.
- r) Dismantle the stall after the completion of the fair and the management of the debris.
- s) (15 Percent Tax (TDS) shall be deducted from the total payment as per the Tax Law of Government of Nepal)
- 3. The selected fabricator should quote the price including all applicable taxes and present the invoice for payment. However, if a company based/registered in India applies, such company has to submit/bid the proposal/quotations in Indian Currency. If such Indian company wins the bid and is awarded the job, in such condition, the company shall be paid in Indian currency (15 Percent Tax (TDS) shall be deducted from the total payment as per the Tax Law of Government of Nepal)
- 4. The selected company shall deal with the organizer in getting all technical approvals/permission/electricity supply/ water connection etc.
- 5. Nepal Tourism Board shall not make any payment for the design or submission of quotation/proposal, which is not selected for the job.
- 6. The posters & designs are to be approved by Nepal Tourism Board before final work.
- 7. NTB shall make payment to the party whose design and quotation/proposal is approved and selected for the job. The modality of payment shall be as per the terms and conditions agreed upon by both NTB and the party selected for this job.
- 8. Nepal Tourism Board shall have sole right to select or reject any design or quotation/proposal in its partial or complete form.

9. 50% of the total amount quoted by the selected stall designer/fabricator will be paid in advance and the remaining 50% will be paid after the successful completion of the event.
