Terms of Reference (TOR) for Stall Fabrication of Nepal Stall at  
SATTE 2023, Delhi, India

Nepal Tourism Board (NTB) is the National Tourism Organization (NTO) of Nepal established to develop, introduce and promote Nepal as an attractive tourist destination.

As an effort for the fulfillment of the same objectives, Nepal Tourism Board is participating in SATTE 2023, Delhi, India, along with 27(Twenty-Seven) co-exhibitors from Nepal. Hence, Nepal Tourism Board requires the professional services of stall fabricators for design, build up and dismantling of Nepal Stall at SATTE 2023, Delhi, India as per following details:

1. Fair Details:

Fair Date: 09-11 Feb 2023

Fair Venue: India Expo Mart, Greater Noida, Delhi NCR, India

Hall No: 12

Stall Specifications as follows:

a. Stall Space: 144 Sq. m. (12mX12m), Four Side open

b. Stall No: D61

c. Total number of Co-exhibitors: 25 + 2 (NTB and NAC) with NTB as Main Exhibitor

2. Scope of Work: Design, Build up and manage Nepal Stall at SATTE 2023, Delhi, India and dismantle the Stall after the completion of the fair.

3. Specific requirements for Stall Fabrication Package for Nepal pavilion:

3.1 Design and erect a heritage/culture style thematic Nepal stall using Nepal's iconic tourism products/destinations.



3.2 Design, print and paste the graphics of Nepalese tourism attractions on the wall panels with backlit. Required number of raw graphics will be provided to the fabricator by NTB in the available format. The fabricator is responsible to redesign or edit the graphics, if any, in the necessary format as per the requirements of the fabricator.

3.3 Dismantle the stall after the completion of the fair. The proper management remains after the dismantling of the stall will be the sole responsibility of the fabricator.

3.4 Provide all necessary logistic arrangements required for the stall including:

- a) Flooring with carpet in the stall.
- b) 1(One) Main reception counter with branding for Nepal Tourism Board(NTB) with two chairs facing isle in the prime location of the stall
- c) Other 26 (Twenty Six) counters (lockable) for co-exhibitors with 2 chairs each on the same side with sufficient space in between (no bar stools).
- d) The 27 (Twenty Seven) Counter Tables with the Name and Logo of the respective Company (Co-exhibitors).
- e) Make sure that there is panel separator or enough space between the co-exhibitors to maintain privacy.
- f) Placement of the co-exhibitors' counter towards aisle side directly facing walkways in the halls.
- g) 6 (six) sets of meeting table with required number of chairs for meeting purpose for co-exhibitors.
- h) Special seating arrangement with 1 (One) sofa set and tea table (if space permits).
- i) NTB Brand Logo should be prominently visible to the visitors and the exhibitors. The Brand Logo has to be used in compliance with the guidelines attached herein. Visit Year Nepal 2020 must not be used as it has already been phased out.





- j) Electrical supply and sufficient lighting for the stall, with plug points/sockets for each counter. Moreover, it is the sole responsibility of the fabricator to coordinate with the organizer to ascertain the required amount of electricity supply to fulfill the required demand of the electricity as per the TOR. NTB shall treat the supply of Electricity as a part of the fabrication. No extra payment shall be made separately for Electricity supply neither to the Organizer nor to the Fabricator.
  - k) Storage room with lockable door in the stall with shelves and hangers.
  - l) Audio/visual display with big LED screen.
  - m) Strong Wi-Fi/internet facility within stall accessible to the exhibitor/s and all the co-exhibitors. Moreover, it is the sole responsibility of the fabricator to coordinate with the organizer to ascertain the strong wifi supply as per the TOR. NTB shall treat the supply of Internet as a part of the fabrication. No extra payment shall be made separately for Internet services neither to the Organizer nor to the Fabricator.
  - n) 1 (One) bigger dustbin for store and other required number of small dustbins in between counters.
  - o) Banner/standee to be kept at the corner of the stall or in any visible area, displaying all co-exhibitors names.
  - p) 2-4 plants at the possible places/corners in the stall.
  - q) Set up 1 (One) coffee/tea vending machine and 1 (One) water dispenser with necessary supplies for all three days at the appropriate place in the stall. Nepali tea must be provided to the exhibitors and co-exhibitor for all three days.
  - r) Stall cleaning service for all 3 (Three) days of the fair.
  - s) Any other effective creative elements for the value addition in Nepal's participation.
  - t) Dismantle the stall after the completion of the fair and the management of the debris.
4. The interested fabricator should quote the price including all applicable taxes. If a company based/registered in India applies, such company has to submit/bid the proposal/quotations in Indian Currency. If such Indian company wins the bid and is awarded the job, in such condition, the company shall be paid in Indian currency upon submission of the Invoice.



5. The selected company shall deal with the organizer in getting all the technical approvals / permission / electricity supply/ water connection etc.
6. Nepal Tourism Board shall not make any payment for the design or submission of quotation / proposal, which is not selected for the job.
7. The posters & designs are to be approved by Nepal Tourism Board before final work of printing and pasting.
8. Nepal Tourism Board may ask the selected fabricator to make necessary changes if any, in the design submitted without violating the basic design.
9. NTB shall make payment to the party whose design and quotation/proposal is approved and selected for the job. The modality of payment shall be as per the terms and conditions agreed upon by both NTB and the party selected for this job.
10. Nepal Tourism Board shall have sole right to select or reject any design or quotation/proposal in its partial or complete form
